They both have 1/100 to 1/100,000 second electronic shutter capability and one or two pulse random triggering for professional imaging applications.

The introduction of the IK-TF5C and IK-TF7C allows customers to choose from five 3CCD one-piece color cameras in the IK-TF series. All IK-TF cameras are ultra-compact, lightweight and equipped with C-mounts for easy integration into space-sensitive machine vision applications. They measure only 44mm x 44mm x 78mm (W x H x D) and weigh a mere 5.82 ounces.
